RE: Division, Consolidation and Redetermination of Benefits and Damages Final Hearings

Dear Landowner:

There will be hearings held on the division, consolidation and redetermination of benefits and damages on Faribault County Ditches #13, 22, 35, and 39 (CD13, CD22, CD35, CD39) and Judicial Ditch #13 (JD13F) held on **Tuesday, July 11<sup>th</sup>, 2023, at 1:30 pm at the Board Room at the Faribault County Courthouse** (415 North Main Street Blue Earth, MN 56013). Redetermination of benefits were ordered for CD13, CD22, CD35, and CD39 on July 21<sup>st</sup>, 2020 and JD13F on March 2<sup>nd</sup>, 2021, due to the benefits not reflecting reasonable present-day land values and change in the benefited area. JD13F is a very large watershed with smaller watersheds within it (CD13, CD22, CD35, and CD39) and also provides an outlet for other public drainage systems. For efficient administration and maintenance of the system and fair and equitable outlet benefits, the Drainage Authority passed a resolution on May 16<sup>th</sup>, 2023, of intent to divide and consolidate the systems. The JD13F system is proposed to be divided into 4 systems and consolidating CD13, CD22, CD35, and CD39 into the divided portions of JD13F (see enclosed map). This meeting will cover the proposed division and consolidations and benefit and damage values. 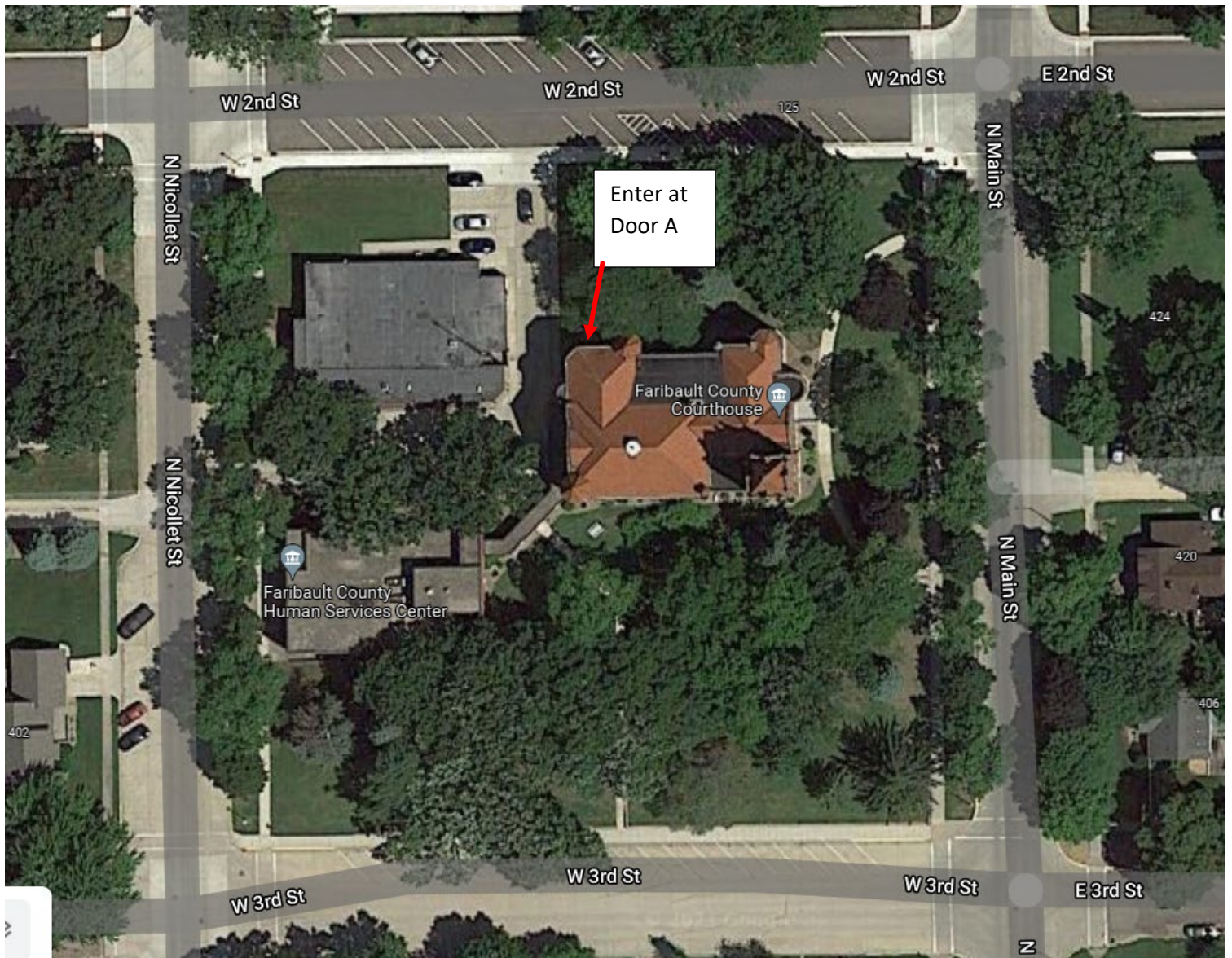

PLEASE TAKE NOTICE, the Faribault County Board of Commissioners, sitting as the drainage authority for Judicial Ditch #13 and County Ditches #13, 22, 35, and 39 will hold a final hearing on the division of Judicial Ditch #13 and consolidation and redetermination of benefits and damages of Judicial Ditch #13 and County Ditches #13, 22, 35, and 39. Judicial Ditch #13 is proposed to be divided into 4 systems and consolidating County Ditches #13, 22, 35, and 39 into the divided portions of Judicial Ditch #13 for efficient administration of the systems and fair and equitable outlet benefits. The Viewers' Reports were filed with the drainage authority on May 30<sup>th</sup>, 2023, and are available for inspection at the Faribault County Auditor's Office, 415 North Main Street, Blue Earth, MN. The hearing shall be held **at 1:30 p.m. on July 11<sup>th</sup>, 2023, at the Faribault County Board Room on the middle level of the courthouse building located at 415 North Main Street, Blue Earth, MN.** The hearing can be attended virtually via phone or computer. Contact the Faribault County Drainage Department at 507-526-2388 for more information on virtual attendance. At the hearings, the drainage authority will accept public comment regarding the division and consolidation of the systems and the Viewers' Reports. Any party having an interest in the proceedings may appear and provide comment. Written comments will be accepted at the hearing and by mail through the date of the hearing at the Faribault County Auditor's Office, PO Box 130, Blue Earth, MN 56013.

Judicial Ditch #13 consists of several branches of open ditch and tile lines and provides an outlet to several other public drainage systems including County Ditches # 13, 22, 35, 39, 78, and 102 and Winnebago County, Iowa Drainage Districts #64 and 102. County Ditches #13, 22, 35, and 39 consist of several tile branches.

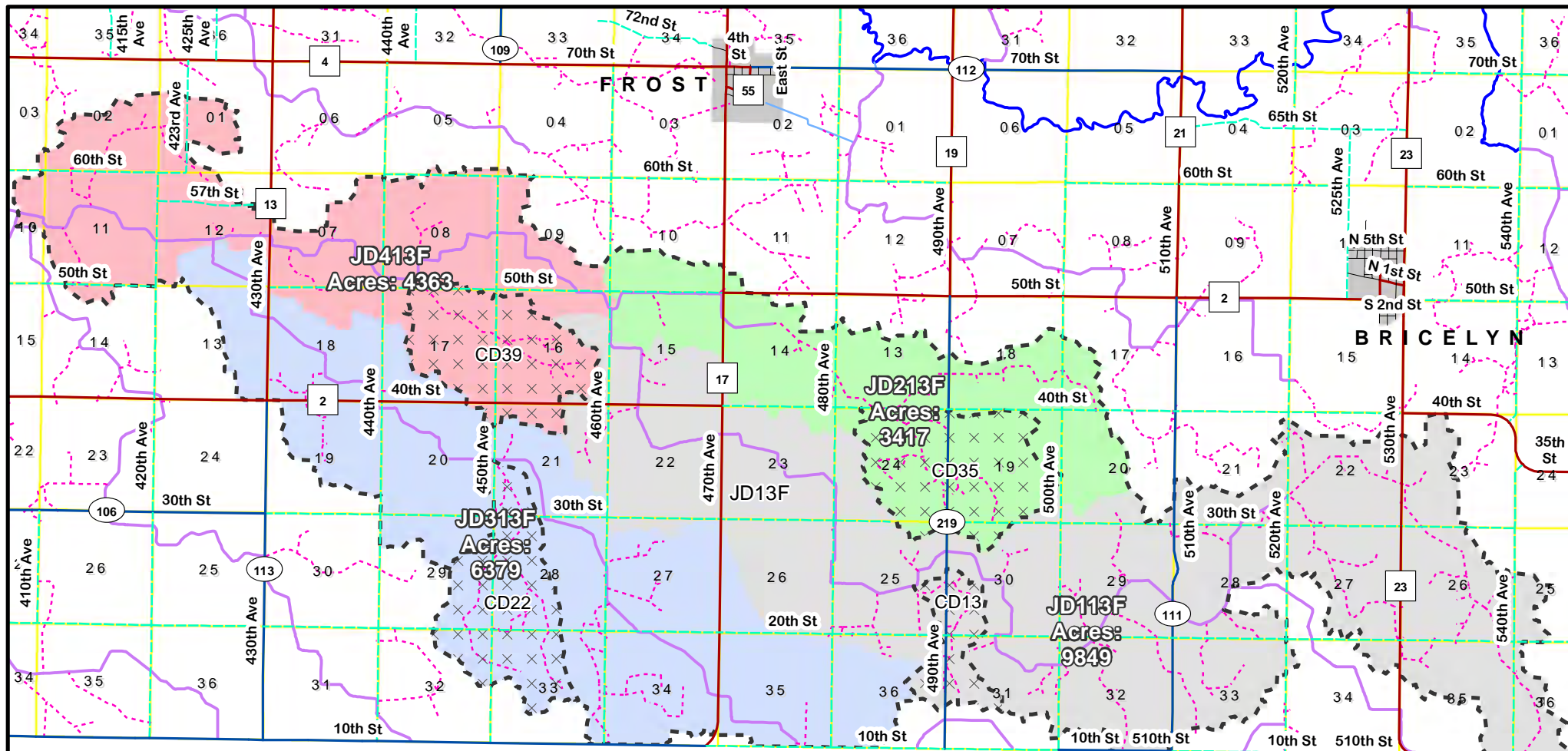

CD13, CD22, CD35 & CD39 Consolidation & JD13F Division

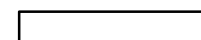
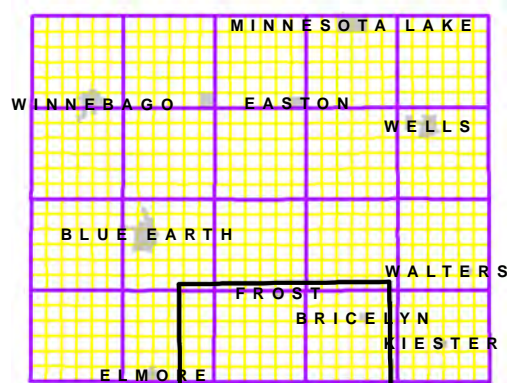
