### INFORMATIONAL MEETING NOTIFICATION

July 15<sup>th</sup>, 2020

System: Faribault County Judicial Ditch #19  
Location: Jo Daviess Township Sections 27-29, 31-34;  
Pilot Grove Township Section 5

Dear Landowner:

Faribault County Judicial Ditch #19 (JD19F) outlets into Faribault County Ditch #514 (CD514). CD514 serves as an outlet for 5 public drainage systems: Martin and Faribault Joint County Ditch #214 (JCD214MF), Martin and Faribault Joint County Ditch #314 (JCD314MF), Martin and Faribault Joint County Ditch #414 (JCD414MF), JD19F, and Faribault County Judicial Ditch #20 (JD20F). See the enclosed map for location reference.

Due to changes in the benefited area and disproportioned outlet fees on CD514, a redetermination of benefits on CD514 was ordered on February 4<sup>th</sup>, 2020. Viewers were appointed for a pending small improvement project anyways and a redetermination of the system will get everything cleared up at once. During this redetermination of benefits, the Viewers have assigned outlet benefits to JCD214MF, JCD314MF, JCD414MF, JD19F, and JD20F.

There will be an informational meeting held on **Thursday, July 30<sup>th</sup>, 2020 at 9:30 am** about the JD19F outlet benefits to CD514. Landowners are encouraged to attend to learn the changes in outlet benefits for JD19F. The Viewers will be present at the meeting to answer questions from landowners.

Due to the pandemic with COVID-19, landowners can join this meeting 1 of the following 3 ways.

1. In person at **Faribault County Courthouse Court Room (415 North Main Street Blue Earth, MN) \*Map on Back**
2. By phone/call-in
3. By Zoom (internet meeting)

Social distancing will be followed if attending in person. Face masks will be required and provided. If you would like to join the meeting via Zoom you will need a computer, internet, microphone, and speakers.
