Dear Landowner:

There will be a final acceptance hearing on Faribault County Judicial Ditch #2 (JD2F) Open Ditch Repair on **Tuesday, December 21<sup>st</sup>, 2021 at 11:30 am in the Board Room at the Faribault County Courthouse** (415 North Main Street Blue Earth, MN 56013). A repair petition was filed on July 31<sup>st</sup>, 2019. The Faribault County Board of Commissioners, acting as the drainage authority for JD2F, ordered repairs to JD2F open ditch on July 7<sup>th</sup>, 2020. The repairs were completed by Brunz Construction Company, Inc. during the 2021 growing season. The Engineer has certified the repair is complete. 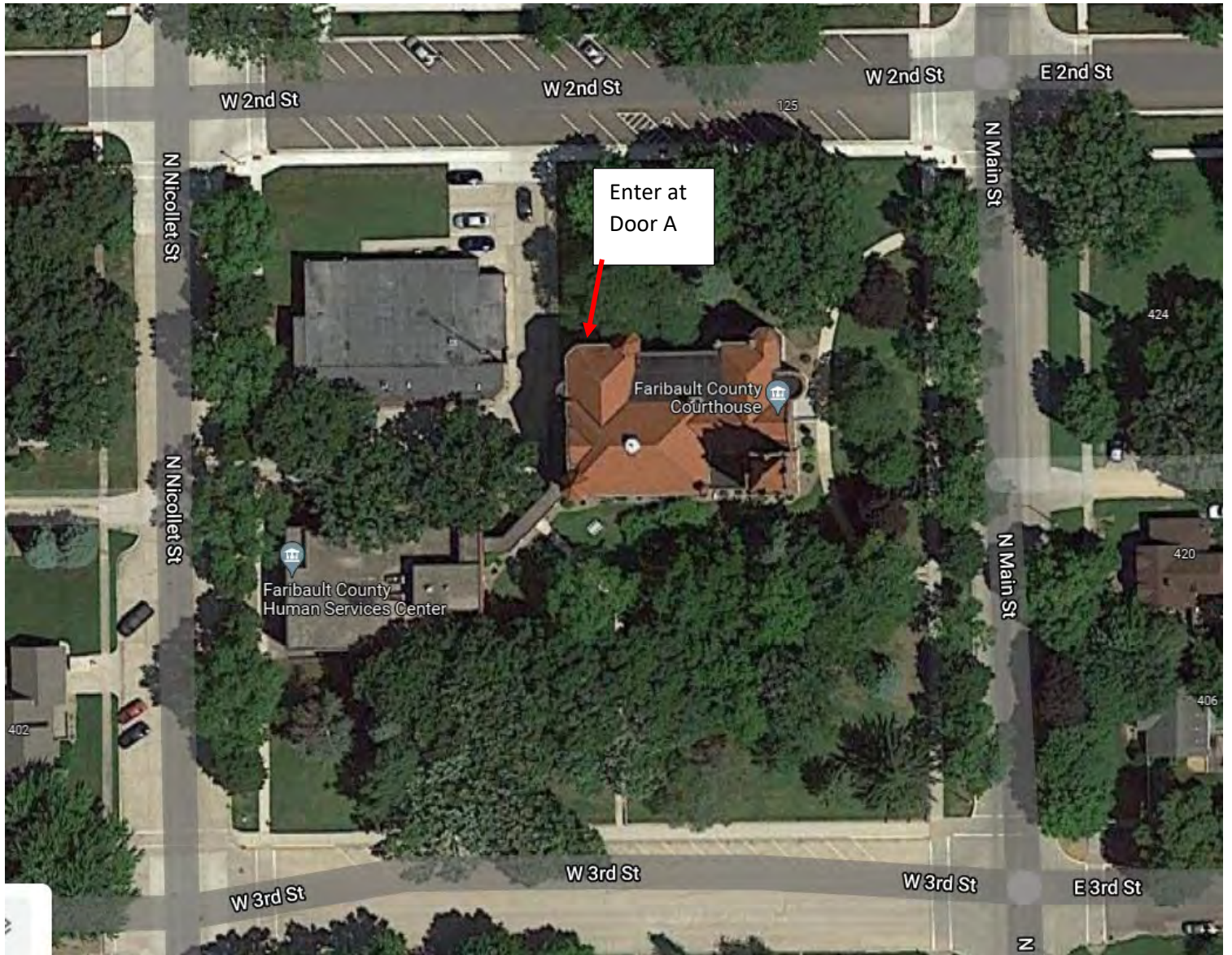


