There will be a final acceptance hearing on Faribault County Judicial Ditch #2 (JD2F) Open Ditch Repair on Tuesday, December 21st, 2021 at 11:30 am in the Board Room at the Faribault County Courthouse (415 North Main Street Blue Earth, MN 56013). A repair petition was filed on July 31st, 2019. The Faribault County Board of Commissioners, acting as the drainage authority for JD2F, ordered repairs to JD2F open ditch on July 7th, 2020. The repairs were completed by Brunz Construction Company, Inc. during the 2021 growing season. The Engineer has certified the repair is complete. 
