There will be a redetermination of benefits and damages and repair hearing on **Tuesday, July 7th, 2020 at 2 pm** on Faribault County Judicial Ditch No. 2 (JD2F). A redetermination of benefits was ordered on July 3rd, 2018. A repair petition to clean the open ditch portions of JD2F was received July 31st, 2019. This meeting will cover the benefits and damage values, as well as the proposed repairs and associated costs. **See enclosed public notice for more information on the proceeding.**
