Dear Landowner:

There will be a repair hearing held on **Tuesday, June 21st, 2022 at 1:00 pm at Average Joe's Conference Room** (115 East 6th Street Blue Earth, MN 56013) on Faribault County Judicial Ditch #6 (JD6F). The Drainage Department completed an inspection and survey of JD6F in the fall of 2021. The inspection and survey indicate repairs are needed to portions of the open ditch. A Staff Repair Report was completed on the recommended repairs. Landowners are encouraged to attend the meeting in-person or virtually on June 21st, 2022. **See enclosed public notice for more information on the proceeding.**


FARIBAULT COUNTY JUDICIAL DITCH NO. 6 (JD6F)
