The Faribault County Board of Commissioners met in regular session via teleconference in the City of Blue Earth at 9:00 a.m. on April 7, 2020. Public Works Director Mark Daly met regarding office business.

Groskreutz/Loveall motion carried unanimously to accept the sole bid submitted by Ulland Brothers for SAP 022-616-027 with the County share at \$3,002,792.32 and City of Blue Earth share at \$275,564.18 for a total contract cost of \$3,278,356.60 . Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

Roper/Loveall motion carried unanimously to accept the low bid submitted by HG Meigs for CP 20-600-01, 2020 Seal Coat Oil in the amount of \$231,990.00. One other bid was received from Jebro for \$261,738.00. Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

Groskreutz/Young motion carried unanimously to accept the low bid submitted by AAA Striping for CP 20-600-10, 2020 striping in the amount of \$83,832.00 . One other bid was received from Traffic Marking Service for \$83,992.00 . Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

Young/Loveall motion carried to delay opening county parks until May 15, 2020. Commissioners Loveall, Young, and Warmka voted yes. Commissioners Groskreutz and Roper voted no.

Groskreutz/Young motion carried unanimously to table discussion of Pihls Park house to the next meeting. Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

Loveall/Young motion carried unanimously to approve the Public Works Director to obtain quotes for 1-inch mill and overlay using the wheelage tax. Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

- **THEREFORE, BE IT RESOLVED**, the Faribault County Board of Commissioners hereby directs the Central Services Director to issue provisional layoff notices to the following employees:

 - 2. License Bureau Secretary
 - 3. Planning & Zoning Administrative Assistant
 - 4. Extension Secretary
- **BE IT FURTHER RESOLVED**, the provisional notice will be revoked or employee will be recalled from layoff status upon work becoming available to the employee to complete from home or upon the granting of non-critical workers to return to work, whichever comes first.
